TERMS

The stud fee is \$600.00 to be paid when the bitch is delivered by the owner. (Three breedings will be attempted.) The stud fee is nonrefundable except under the terms of this contract.

In some special situations an artificial insemination will be provided but only after the bitch's owner has been notified and approves of this method.

If the bitch fails to conceive or no live puppies are born at time of whelp the owner will get a free studding with the same or equivalent bitch.

We reserve the right to display images (pictures) on our website www.gerdeshaus.com of the bitch and or any progeny produced by the litter conceived with Arkan indefinitely. All transportation charges and veterinary expenses will be the responsibility of the owner of the bitch. There is no charge for boarding the bitch for the first seven days, after which the charge will be \$10.00 per day. This fee includes food, water, and exercise. The owner of the bitch warrants that this bitch has not been exposed to any stud dog prior to her arrival and that she will be protected from such exposure after her return home.

The owner of the bitch hereby releases from responsibility GerdesHaus German Shepherds, GerdesHaus Kennels, Jeremy Gerdes, Amanda Gerdes or their officers from any and all liabilities and/or damages to said bitch while she is in the care of GerdesHaus Kennels for breeding.
